

## CRAGC MONTHLY MEMO

APRIL 30, 2020

As the Covid-19 situation continues, CRAGC is forging ahead on work with the five religious institutes we have as service partners. The journey from congregational leadership to governance by a commissary involves a number of phases and we are currently working with two institutes moving from phase one to phase two.

While not being able to work in person with the leadership groups of these two institutes does present some challenges, we have made steady progress over the month thanks to Zoom and a lot of goodwill and good humour!

As we expected due to the Covid-19 situation, we have heard nothing from CICLSAL since President Peter Carroll fms delivered our petition on February 27. Given that we have no idea how long the current situation will extend, particularly in Rome, we have begun to consider interim alternatives for commissaries. There are other models for commissary provision used in other countries and CRAGC will explore those other models and find the best for our Australian circumstances.

On Monday May 4, the Executive Team of CRAGC have a planned Zoom meeting with the CRA Council Executive to consider how to assist religious institutes in need of a commissary before CRA receives a positive response to its petition to CICLSAL.

The first meeting of the CRAGC Transition Committee occurred by Zoom on April 8. Anne Lane led a 'getting to know you' session to begin our meeting and then Judy Lawson invited us into reflection and prayer around the central vision of the Governance Collaborative. Peter Cranko stepped us through the history, the set-up plans and focus areas, the work occurring with service partners and the next steps. A discussion about possible work parties for the Transition Committee led us to schedule some conversation Zooms: with fourteen people on screen at a Committee meeting, it's quite difficult to have conversation, so we will be meeting in much smaller groups to explore some possible working party ideas prior to our next Transition Committee meeting on May 5.

One of the ideas from the Transition Committee meeting is being rolled out this month. John Thompson suggested that we create a simple newsletter each month that leaders may distribute to their members to begin to inform the general membership of institutes about the issues facing religious life in Australia and the response of CRA through CRAGC to those issues. Consequently, we have put together a two-page newsletter that we hope you will send out to your congregational members. I will provide one newsletter a month at the same time as the Monthly Memo to leaders and team members.
