The board of directors convened at 12:45 PM. The business portion of the meeting paused from 1:00 to 2:00 PM for a presentation by Mary Jo Nelson, OLVM, to the joint leadership teams about the various steps an institute needs to take before requesting a commissary. Following her presentation, the business meeting resumed.

Approval of Agenda

Diana De Bruin, OSF, moved, and Sharon Glumb, SLW, seconded the motion, to approve the agenda as presented. Motion carried.

Approval of Minutes

Sharon Pollnow, CSA, moved, and Mary Ann Pevas, OP, seconded the motion, to approve the March 20, 2023 minutes as presented. Motion carried.

Treasurer's Report

Sue Ernster, FSPA, presented the treasurer's report. As of March 31, 2023, net assets totaled \$292,260.84. YTD revenues totaled \$191,695.90, and expenses totaled \$81,024.10, for a net operating gain of \$110,671.80. Expenses incurred in April for the website will be shown on subsequent reports.

Sharon Glumb, SLW, moved, and Angelo Collins, OP, seconded the motion to accept the treasurer's report. Motion carried.

Budget Draft

Pat Cormack, SCSC, presented a budget draft for FY 2023-2024. The draft assumes a top salary of \$111,905 for the new position of Director of Shared Services and that 75% of the budget will be paid from member dues. We will not know the precise amount of dues each member institute will pay until this year's NRRO figures are available. However, based on last year's NRRO figures and current census numbers, institutes are likely to see an increase of between \$2,000 and \$7,000 in annual dues.

Some members expressed concern about whether their institutes could afford such a significant increase. Others said that they might be willing to make additional contributions, if needed.

The board agreed to postpone a vote on the budget until this year's NRRO numbers are available. Sue will let members know what numbers on the NRRO form to report.

Search for Director of Shared Services

Pat Cormack, SCSC, said that the Search Committee will meet on May 24 for a conversation on how we can reinvigorate the search process. She asked board members to be creative about reaching out to potential candidates. Information about the position is on the landing page of the WRC website.

Board of Review

Angelo Collins, OP, presented a draft of a document entitled "Review Boards During the Investigation of Allegations of Sexual Abuse," which outlines policies and procedures for

creating a board of review, as needed, from among WRC board members. Following discussion, Angelo agreed to tweak the document and bring it back for consideration at the July board meeting. Board members are asked to send suggestions to Angelo by June 20.
