## **POSITION FUNCTION**

In conjunction with the Health Care organization that serves the Sisters of the living word (SLW), plans, directs and organizes the delivery of LifeStyle Options, Inc. services in assigned case load in a manner that ensures that quality standards consistently meet or exceed the established philosophy, expectations and goals of the company.

#### **ESSENTIAL DUTIES AND RESPONSIBILITIES**

- 1. Performs care coordination for all residents in the SLW organization including those in Assisted Living and Independent.
- 2. Responsible for opening new cases and insuring that the resident care plan is appropriate for the level of care needed. Monitors the care plan to ensure that resident needs continue to be met.
- 3. Completes or insures that all resident paperwork is completely filled out, signed by appropriate persons and submitted to SLW.
- 4. Attends all resident assessment meetings and implements plan for resident service.
- 5. Primary contact with Resurrection Life Center and other case managers outside of Illinois.
- 6. Communicates with Director of Program Services regarding the Sister's health status and any issue regarding their health.
- 7. Directs health care programs/on-going education especially for the aging sisters. Communicates with the Sisters of any and all workshops they may be interested in.
- 8. Responsible for carrying a cell phone for access from on-call staff.
- 9. Interface with Medical Records Manager, and Eligibility Specialist for Government Programs
- 10. Provides updates in monthly newsletters and mailings.
- 11. Other duties may be assigned.

## **QUALIFICATIONS**

- 1. RN, and at least 2 years experience in Geriatrics
- Excellent verbal and written communication skills.
