I hope you and your community are staying well and safe during these uncertain times.

As you know in May we cancelled the in-person RCRI 2020 Conference scheduled for September 28 - October 1. At that time we announced that we would plan an alternative virtual conference in the Fall. Recently we announced that we would be holding a virtual conference for three consecutive Friday afternoons on October 23, 30 and November 6 from 12:00 noon – 4:00 (EDT). The condensed program will include an Exhibit Hall and two sessions each Friday with three webinar offerings per session. Eighteen webinars will be offered for the series.
