RELATED WI LEGISLATION:

Safe Harbor: Bill 245 SB245 - protects minors participating in prostitution and treats them as sex-trafficking victims

Runaway Youth Shelter Bill – not yet introduced: requires earlier notification of protective agencies when youth arrive at shelters

LCWR9 CONGREGATIONS continue collaborative anti-human trafficking efforts in several areas around the state.

Madison Diocese: Sept 17, 2021, gathering hosted by Bishop Hying and attended by more than 50 people, mainly from law enforcement, people from Catholic parishes in the diocese, and members of local organizations working against human trafficking
