## LCWR Matters Part 1: Spirit Call within A Call: Racism

S. Sharon Glumb shared the efforts LCWR is doing, as an organization, to dismantle racism step by step and little by little. The board, regional chairs and national office meet monthly with Kathy Obear. All of her materials, including her book, <u>But I Am Not a Racist</u> and *Suggested Competencies for White People*, are available for all LCWR members to use with their own congregations. (See LCWR website). After watching two YouTube clips, we met in small groups and shared our thoughts and feelings around the materials. Then we met in large groups and shared insights. ## LCWR Matters: Global Concerns Committee

S. Kathy Slesar, OP facilitated the process. We discussed the LCWR Resolution on the intersection of racism, migration and climate crisis. We watched a video from the LCWR Global Concerns Committee that shared trends from the Fall 2020 LCWR responses along with some current initiatives and possible conclusions. We then had large group discussion on these two questions: 1) What key reflections can you share from your discussion on the intersection of these three areas? 2) Where does our region go from here? Share specific actions, networks, structures, conversations occurring now or in in the works.

Actions: some of our ideas are: work with the *Laudato Si* Initiative; learn more about the Catholic Climate Webinar which spoke about the intersection of the Native experience of colonialism; ask LCWR to speak to the Vatican about renouncing the Doctrine of Discovery; learn to dialogue about difficult and divisive issues; LCWR 9 share our priorities with the LCWR Region 9 Legislative Network; discuss the book, <u>But I Am Not a Racist</u>; take actions on behalf of the oppressed; make public statements as needed. ## Presentation "Understanding Indigenous People"

S. Ellen introduced our speakers, Adrienne Thunder, Division Manager, Ho-Chunk Language Division and JP Leary, Asst. Professor UW Green Bay, both Native Americans. They shared many stories from their experiences, especially on the need for more education about Native Americans, their history, rights, their lands, their practices with regards to fishing and hunting, their ongoing oppression, and the wide gap in access to resources, especially for health care and treatment of mental health issues, trauma, alcohol/drug addiction and meeting some very basic needs. They offered many helpful resources and encouraged us to keep learning. What do we already know? What do we need to know?

# Funds from Sisters for Justice

S. Rose shared a request from the FSPA's. They have held funds for the Sisters for Justice to use for lobbying efforts. No funds have been used since 2012; current balance is \$510.00. They asked if the funds could be transferred to LCWR Region 9. Before we could decide, need more information regarding any fees or licenses that may need to be paid from this fund. S. Rose will follow-up. The decision on their request was deferred until our October 2021 meeting.

#### WISCONSIN RELIGIOUS COLLABORATIVE REPORT

Lyn Korte, WRC Executive Director, presented her report. She clarified that the annual May meeting is for the entire leadership team of member congregations, not just the one representative on the WRC board. The May meeting builds relationships, helps newer members to learn more about the WRC, offers more accountability and enables the WRC to hear more voices. Besides offering presentations to member congregations, S. Kathy Slesar shared that Lyn offers very insightful presentations to non-member congregations as well.

## LCWR Legislative Network Report

S. Toni Harris shared her report. She is our regional liaison to the Legislative Network. In addition, Ss. Rose Jochmann, Ellen Sinclair and Kathy Slesar are also members. We are invited to send ideas to S. Toni for issues for the Legislative Network to consider. Some areas are: Native Americans and mining rights and land use; Catholic Climate Covenant group and *Laudato Si* efforts and education; issues related to racism. Note: Catholics at the Capital offered a virtual advocacy day this year on Apr. 21 instead of an in-person event.

## LCWR 9 Officer Election of Corresponding Secretary

There were two nominees: S. Cyndi Nienhaus and S. Toni Harris, current corresponding secretary. After taking a poll of members, S. Toni Harris was re-elected to serve as our corresponding secretary.

## WI Council of Churches Report

S. Cyndi Niehaus shared the report. One additional activity to include is that many churches are encouraging people to get vaccinated. We need to take care of one another.

# Anti-Human Trafficking Report

S. Toni Harris shared the report. She is currently our representative and asked if another LCWR 9 member is willing to take that role. Many congregations have a team working to stop trafficking. S. Rhea Emmer shared a new resource about the "Dirty Dozen" that names several large businesses involved in trafficking. We will share the link on our website.

#### Topics and Dates for Future Meetings

S. Ellen Sinclair led the discussion.

<u>October 2021 Meeting</u>: We are scheduled to meet in Racine from October 11 - 13, 2021. Right now we do not know if we will meet in person or virtually. If we meet in person, it will be on Monday Oct. 11 afternoon, all day Tuesday Oct. 12 and Wednesday Oct. 13 morning. If we meet virtually, it will be for 2 full days on Oct. 12 and 13, like our Spring Meeting. Choice of speakers also depends on how we meet; not all want to offer a program virtually. We will take a survey of members and ask their preference for our October meeting.

<u>Prayer</u>: Bay Settlement Sisters and A New Genesis Host: The Lake Franciscans

<u>Speakers/Topics raised:</u> Process COVID and being apart; with LCWR's five-year focus on racism, continue to explore the topic - e.g., Father Joe Cheah on anti-Asian sentiment; Dan Horan OFM, at CTU, offers a great program on Beyond *Laudato Si*; a program on the future of religious life; S. Sheila Kinsey on the launch of *Laudato Si*; S. Carol Zinn and S. Pat Murray: What West needs to learn from the East? Offer both some sharing on the impact on COVID and a larger focus; have a panel on Multi-Cultural experience

<u>Dates for Spring 2022 Meeting:</u> members are asked to send dates for their Chapter so we can avoid those dates when we set the date. Once we have that information, we will send a doodle poll to determine the date of our Spring 2022 meeting.

The Executive Committee will discuss options, based on the results, at their next meeting.

#### Looking Ahead: What Gives Us Hope?

S. Sharon Glumb facilitated this discussion, with both small and large group sharing, on what gives us hope. Our answers included: ways we meet face to face, learning the "essence" of a person; we stop, are patient and give others time; the way we stopped and prayed for peace before the verdict; ways to expand racism beyond Black people, include Native Americans and think more broadly; important to be together, we are still

in solidarity on a screen and are present to each other; gifted to have Brittany, she did more than technology, helped us learn more about Nuns and Nones, her love and appreciation for us was a gift, she brought lots to us; we had fun-music and dance-will remember that; since October, it is evident that there is still "fire in these ashes," congregations are doing many things, Spirit is moving, we are going to fulfillment, not completion.

#### **Closing Prayer and Blessings**

S. Sue Seeby led our closing prayer about going forward, with hopeful energy in our emerging future and offered blessings for members, especially Carol Haanen, from New Genesis, since this is her final meeting with us.
