- 2022 Legislative Prayer Partners – Jill Haberman
  - 8 communities signed on this year with 194 participants. This is an increase over last year: 5 communities and 170 participants. It was possible to add the U.S. Senators from Wisconsin. A reminder will be sent in June – to continue this prayer until the end of the year. Thanks to the participants and to Jill for organizing this.

- Earth Day Prayer for 2022 – Discussion
  - There was an extended discussion on whether or not to prepare an Earth Day Prayer 2022

- Tim reminded us that Pre-COVID, the intent was that religious communities across the state would host a contemplative prayer event. It would be a public event, inviting others from the local community to participate. The Zoom event last year was appreciated by religious communities in the Wisconsin, but that was not the original intent to ask the public the stand with us.
- It was decided that the Earth Day prayer event be put on “pause” for this year. Hopefully next year local groups can meet in person.
- Other groups around the state and nation will likely offer Earth Day prayers on Zoom. For our meeting in March, members are asked to note what is being offered and bring ideas to the meeting. We may be able to make a unified suggestion to LCWR members for an Earth Day prayer. **This will be an agenda item at the next meeting.**

## V Defining Leg-Net Collaboration with WRC Topics for Discussion

- Jill introduced this topic of defining our collaboration with WRC and what that means. The Legislative Network was founded around the idea of working together on topics that are being address in the Wisconsin legislature. At the same time, emphasize the issues key to the national LCWR: the intersection of Creation, Immigration, and racism. In addition, our Legislative Network has concentrated on Human Trafficking.
- Sr. Toni reminded us of the decision recommended by this group and approved by LCWR 9.
 

“The Women Religious Collaborative (WRC) stated that the social justice portal “committee members will be expected to contribute expertise, advise on direction, assist in identifying additional resources, and facilitate connections.” Based on our experience as the Legislative Network of LCWR Region 9, we believe that we are in a position to contribute the work of our committee and its members to (WRC). Rather than forming a WRC social justice committee, which would likely draw members from the people already serving on the Legislative Network, we propose that LCWR 9 Legislative Network be the Peace and Justice “arm” of WRC offering the following services:

  - Analyze Wisconsin legislation and recommend action
  - Carry out LCWR National issues: currently the intersection of Racism / Climate change / Migration
  - Share resources: among communities (those with hired staff share with those with no hired staff)
  - Facilitate collaborative response on current justice and peace issues
  - Stay connected with other Wisconsin groups on issues such as Catholics at the Capital and Wisconsin Catholic Conference

We propose that the director of WRC be part of LCWR 9 Legislative Network.

We believe that, with the collaboration of the different communities’ communicators, a system to facilitate this kind of sharing via WRC can be established.”

- It was suggested that Julie be added to those receiving the Justice Alerts e-mailed by Tracy Abler every 1<sup>st</sup> and 3<sup>rd</sup> Thursday of month.
- Next, we decided that it would be helpful to assign one person from this group to be a “point person” for each of our topics of emphasis. These Point Persons will share any information that would be relevant to the whole group.
  - Immigration - Tim
  - Racism - Tracy
  - Trafficking – Reg
  - Juveniles without Parole / Restorative Justice (from Wisdom groups) – Tracy (?) or Mary Jo (?)
  - **Care for Creation / Laudato Si – No point person since we are all doing different work for the LS Action Platform in our communities; instead we will share updates at each Leg-Net meeting.**

## VI Sharing on Legislative actions under-way in Leg-Net member communities

As indicated on the agenda, members shared actions by their respective community

- **Creation**
  - **From Barb Thomalla**  
Last year's Earth Day prayer is on the You Tube site for the FSPAs; <https://www.youtube.com/watch?v=eUBEtBQj8D0>
  - **Laudato Si:** Reg and Tracy are in the process of signing up. Rose and Tim are moving toward that.
  - **Ellen:** distributing pollinator seed packets
  - **Kathy:** purple martin habitat has been developed
- **Immigration**
  - Jill and Steve assisted at Fort McCoy the week after Christmas
  - Lutheran Social Service, Milwaukee, is re-settling 500 Afghan refugees. Donations of clothes, blankets, etc. are being accepted
  - Green Bay Diocese is re-settling 100 Afghan refugees. Donations for various kits have been solicited: kitchen, bathroom cleaning, etc. Job placement in meat packing plants is not appropriate to Afghan's religious customs of preparing meat.
  - Ask Pres. Biden to end Title 42: Centers for Disease Control and Prevention can determine whether communicable disease in a foreign country poses a serious danger to those coming to our country.
  - Sinsinawa – Sisters who have been at the border are sharing their experiences
  - Build Back Better bill: includes justice for immigrants, farm workers, Dreamers

SSND is asking Sisters participate in a Training Session: put together by the Polaris Project, a leading national anti-trafficking organization, [Human Trafficking 101](#) is a free, one-hour training session comprised of six modules which address what human trafficking is, how it happens, who the victims and traffickers are, highlights the importance of knowing the story vs. knowing the signs, and discusses what we can all do in the fight against human trafficking. In March, the St. Bakita Catholic Worker House is opening – a safe place and services will be provided for women who have been trafficked.
  - **From Reg McKillip**  
*The Safe Harbor Bill (S 245) would prevent minors (any child under 18) from being prosecuted for prostitution and treat them as sex-trafficking victims. Current Wisconsin law states that someone under 18 may be prosecuted for prostitution despite the fact that Wisconsin law also states that minors cannot legally give consent. Similar bills have passed in 29 states and Washington, DC*

*In October 2021, the Safe Harbor Bill passed out of committee in the Senate. However, it has not yet been voted by the full Senate. The Assembly version has not yet had a public hearing. This bill does have bipartisan support. However, a misunderstanding about the bill seems to have held it up in the Assembly. Some feel it will legalize prostitution. However, prostitution is illegal in Wisconsin, and it will remain so. The Safe Harbor bill only prevents child victims from being prosecuted for prostitution.*

*Contact your WI state representative to encourage him/her to do what is needed to get the Safe Harbor Bill a committee hearing and passed in the Assembly.*
